For the safety of the children, the School Board of Highlands County requires volunteer applicants to undergo a Florida Department of Law Enforcement criminal background check. Instructions:

- 1. Highlands County Schools will arrange payment of the non-refundable \$25 Background Screening Fee. Therefore it is important to carefully consider the 31 week ReadingPals commitment before completing the application.

- 3. The Highlands County School Board requires all volunteers to fill out an application online at http://www.highlands.k12.fl.us/SBHC/HR VolunteerInfo.html Or www.highlands.k12.fl.us Select "Community" tab, select "Volunteer Information".
- 4. Pictures for security badges will be taken at the district office after approval of the application. Badges will be distributed at each school.

If you have been convicted of murder, sexual offenses such as sexual battery, lewd or lascivious acts, soliciting lewd acts or indecent exposure, sexual misconduct, prostitution or solicitation of prostitution, obscenity or pornography, contributing to the delinquency/dependency of a child, abuse/neglect, drug related charges, kidnapping or battery to a child, criminal driving offenses, you will not be approved.
